## The essentials in brief



### Travel documents

To enter Switzerland, you need a recognised and valid travel document. This can be a passport or an identity card. In some cases, a visa may be required.



### Road fees

If you are travelling in a vehicle, road fees apply for driving on Swiss roads and motorways.



### Goods and special cases

You must comply with certain regulations and may have to pay customs duties when crossing the border with goods. Special provisions apply to certain categories of goods (animals, vehicles, internet purchases).

## Road fees

Depending on the type and weight of the vehicle, the following fees must be paid before using Swiss roads:



### Up to 3.5 tonnes

The **motorway charge sticker** costs CHF 40.– and is in principle compulsory when using motorways with motor vehicles and trailers weighing up to 3.5 tonnes.

**i** The e-vignette will be introduced in the second half of 2023 and will be available in addition to the existing adhesive sticker.

### Over 3.5 tonnes

For vehicles with a total weight of more than 3.5 tonnes, the lump-sum heavy vehicle charge (PSVA) applies.

# Private goods

## Private goods that can be imported duty free

### Personal effects

- Goods temporarily taken abroad from Switzerland
- Goods temporarily brought into Switzerland by foreign travellers

### Travel provisions

- Beverages (non-alcoholic) and foodstuffs intended for the day of travel
- Fuel in your private vehicle's tank

## Restrictions and bans



### Animals and plants

Do you want to import an animal? Travel with your pet? Bring in an exotic plant? Find out what is permitted.



### Prohibited goods

Importing certain goods is prohibited and/or restricted (weapons, drugs, narcotics, cultural goods, counterfeit goods, medicines, etc.).

## Specifics



### Vehicles

When importing a vehicle into Switzerland, you must comply with certain formalities and pay various fees.



### Household effects, inherited goods and wedding trousseaux

If you are moving abroad or moving to Switzerland, you can bring your household effects, inherited goods and wedding trousseaux with you without paying any taxes or duties. An import written declaration is required.



### Internet purchases

Consignments to and from abroad are treated as commercial goods. The VAT-free allowance of CHF 300.– does not apply.

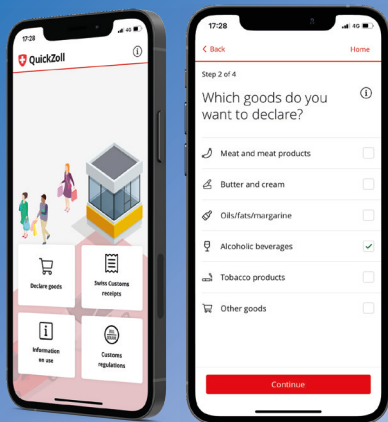
